fee of two hundred dollars. Any expense of litigation or othereise, including attorney's fees and an abstract of tatle to said pemises, incurred by reason of this mortgage, or to protect its lien, shall be repaid by the mortgagors to the mortgages or assigns, with interest thereon at 10 per cent per annum, and this mortgage shall stand as security therefor.

An additional and collateral security for the payment of the note and indebtedness hereinbefore decribed, the said parties of the first part hereby assign to the said party of the second part, its successors and assigns, all the profits, revenues, royalties, rights and benefits accruing to them under all oil, gas or mineral leases on said premises.
