examination of title in preparation for foreclosure, any expense incurred in lotigation or otherwise, including attorney's fees and an abstract pf title to said premises, incurred by reason of this mortgage, or to protect its lien, shall be repaid by the mortgagors to the mortgagee, or assigns, with interest thereon at ten per cent, per annum, and this mortgage shall stand as security therefor;
