AND WHEREAS, on July 24th, 1912, said Usher Carson assigned said lease to the Oklahoma and Missouri Oil Company, a corporation, said assignment being recorded in book 136 at page 400 of the records of the Register of Deeds of Tulsa County, Oklahoma;

AND WHEREAS, On My 31st, 1912, R. N. Eggleston executed and delivered to Usher Carson an oil and gas lease, said lease being recorded in book 113 at page 568 of the records of Tulsa County, on the following described premises, situate in said Tulsa County, State of Oklahoma, to-wit:

All of Block One (1), except Lots 1, 2, 3, 11, 12, 17, 18, 19, 20, in Freeland's Addition to Red Fork, Oklahoma, according to the recorded plat thereof;

AND WHEREAS, on August 12th, 1912, Usher Carson assigned said lease to the Oklahoma and Missouri Oil Company, a corporation, said assignment being recorded in book 136 at page 399 of the records of the Register of Deeds, in and for said Tulsa County;

AND WHEREAS, on March 18th, 1915, said Oklahoma and Missouri Oil Company, the assignee as aforesaid of both the said lease of April 5th, 1912, and the said lease of May 31st, 1912, assigned all its right, title and interest in and to said leases to W. W. Syfert, said assignment being recorded in Book 175 at page 27 of the records of the County Clerk in and for Tulsa County, Oklahoma;

AND WHEREAS, on April 16th, 1915, said W. W. Syfert assigned all his right, title and interest in and to said leases to the Centralia Oil and Gas Company, a corporation, said assignment being recorded in book 183 at page 147 of the records of the County Clerk in and for Tulsa County, Oklahoma;

AND WHEREAS, Said assignment erroneously described Usher Carson as the lessor in said leases instead of lessee, and erroneously describes the Oklahoma and Missouri Oil Company as the lessee in said leases instead of the assignee thereof;

AND WHEREAS, said assignment also erroneously described the dates of said leases, giving instead the dates of the assignments to the Oklahoma and Missouri Oil Company.

AND WHEREAS, Said assignments contain other errors;

AND WHEREAS, the Coronado Oil Company is the present owner and holder of said leases and is desirous of having said mistakes and errors in said assignments corrected by new assignment;

NOW, THEREFORE, for and in consideration of the sum of One (\$1.00) Dollar, and other good and valuable consideration, said W. W. Syfert does, by these presents, bargain, sell, transfer, convey and assign unto said Coronado Oil Company, a corporation, its assigns and successors, all his right, title and interest in and to the oil and gas leases above described, to-wit:

1. The lease of April 5, 1912, by and between Fletcher Oil Company, a corporation, and Usher Carson, and covering the following described premises, situated in Tulsa County, Oklahoma:

All of Block One (1); Lots 5 to 13, inclusive, and 18-25, inclusive, in Block 2; 1 to 17, inclusive, and 20 to 29, inclusive, Block 3; Lots 1, 13, 14, 22, 27 to 32, inclusive, Block 4;
