

chusetts Bonding and Insurance Company, the surety upon the official bond of said trustees, be and they hereby are discharged and released from all liability as to all matters and things embraced within the said account filed herein.

IT IS FURTHER ADJUDGED that none of the funds or securities comprising said trust estate are commingled with the funds or securities comprising the estate of the said Edwin L. Wage, deceased, and that none of the funds or securities comprising said trust estate are held by or are in the custody of the executors of the estate of said Edwin L. Wage, deceased, or either of them.

IT IS FURTHER ADJUDGED AND ORDERED that C. Royce Sawyer, said surviving trustee, under said trust agreement, or his successors in office, commencing August 1st, 1922, deduct from the income of Catherine G. Hill, beneficiary therein named, the sum of Five Hundred Dollars (\$500) peryear to be applied to the restoration of said trust fund up to the amount of \$65,000; that after said trust estate is restored to the sum of \$65,000 as aforesaid, that thereafter the entire interest and income of said trust estate shall be paid, less the lawful commissions of said trustee, either to Catherine G. Hill, or to the committee of her person and estate as the case may be.

IT IS FURTHER ADJUDGED that Fluhrer, Reed & White attorneys for the plaintiff, be allowed for their services and disbursements in this action, the sum of \$1140.93 to be paid by C. Royce Sawyer as said surviving trustee.

IT IS FURTHER ADJUDGED that the report of George A. Larkin, referee, filed herein, is in all things confirmed.
