Dan Danciger, of lawful age, after being first duly states on his oath that he is a resident of Tulsa County, Oklahoma, and has been for a number of years, and that he knows and is well acquainted with the following described land, to wit:

The North Half of the Southwest Quarter ( N $\frac{1}{2}$  of SW $\frac{1}{4}$ ) of Section Six (6)

Township Eighteen North (18-N) Range Thirteen East (13-E) Tulsa County, Oklahoma, the tract containing Eighty (80) acres. more or less.

Affiant further states that there have been a number of oil and gas leases on said land, two of which he was interested in; the first one dated March 18, 1917 was owned by R. C. Rebholz, James R. Kline, Dan Danciger, T. O. Williams, trustee, and George Rebholz; a second lease dated June 18, 1918 was owned by the affiant, and an older lease owned by W. T. Daley dated November 16, 1911 .

Affiant states that under one of the above leases there was one well drilled for oil and gas, but that it proved to be a dry hole, and that there has been no other drilling under either of said leases he was interested in, and that the affiant and his associates have paid no rentals since the expiration of the last lease, March 18, 1919, and claim no interest in said leases at this time. Affiant further states that he knows of his own knowledge that there is not now, nor has there ever been, any production of oil and gas on the above described land.
