

(1) A tract of land located in the Northeast quarter (NE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Five (5), Township Twenty-one (21), North of Range 5, E.1. M. Described more particularly as follows: to-wit: Beginning at a point 33.0 feet south of the 1/16 Section corner, located at the N. W. Corner of the Northeast Quarter (NE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 5, said 1/16 corner being marked by a sand stone; thence south 22° 03' East a distance of 52.2 feet along said center of Black Bear Creek, thence due west parallel with Section line a distance of 458.5 feet to a point in the West line of said Northeast quarter (NE $\frac{1}{4}$) of Northwest Quarter (NW $\frac{1}{4}$) of Section 5, Thence north along the 1/16th Section line a distance of 48.5 feet to place of beginning, containing 0.5 acres, more or less.

The following described real property, situate, lying and being in the County of Payne, State of Oklahoma, To-wit:

A tract or parcel of land located in the south West Quarter (SW $\frac{1}{4}$) of Section Thirty-four (34), Township Eighteen (18) North, Range Five (5) East, described as follows: Beginning at the intersection of the Section line between Sections Thirty-three (33) and Thirty-four (34), Township Eighteen (18) North, Range five (5) East, with the North boundary line of the Missouri, Kansas & Oklahoma (now the Missouri, Kansas & Texas) Railroad Company; thence north on said Section line Ninety-one and seven tenths (91.7) feet; thence running due East to the North boundary line of said Railroad Company; thence running Southwesterly along said north boundary line to the point of beginning.
