All steam electric plants of said Shawnee Gas and Electric Company now owned or hereafter constructed or acquired, and any additions to and extensions of any such existing or future plants, together with the power houses, buildings, erections, structures, dynamos, turbines, generators, transformers switchboard equipment, machinery, tools, instruments, apparatus, appliances, facilities and other property used or provided for use in the construction, maintenance, repair and operation of said plants, both those now owned and those which may be hereafter acquired, and the rights of way, privileges, franchises, easements, licenses, liberties, immunities, permits, grants, and ordinances of said Shawnee Gas and Electric Company, howsoever conferred or acquired and whether now owned or hereafter acquired, with respect to the construction, maintenance, repair and operation of said plants and each of them.

All electric transmission and distributing systems of said Shawnee Gas and Electric Company and all electric transmission and distributing systems hereafter constructed or acquired by said Shawnee Gas and Electric Company, and any additions to or extensions of any such existing or future electric transmission and distributing systems, together with the pole lines, poles, wires, cross arms, insulators, transformers, meters, buildings, structures, stations, substations and superstructures, generating, distributing and transmitting and equipment, cables, conduits, tools, instruments, appurtenances, appliances, machinery, facilities and other property now used or provided for use, or hereafter acquired for use, in the construction, repair, maintenance and operation of such systems, including both those now owned and those which may be hereafter acquired by said Shawnee Gas and Electric Company, and together also with all the rights, privileges, franchises, easements, licenses, ordinances, grants rights of way, liberties, immunities, and permits of said Shawnee Gas and Electric Company howsoever conferred or acquired, and whether now owned or hereafter acquired with respect to the construction, maintenance, repair and operation of said electric transmission and distributing systems and each of them, and any additions thereto or extensions thereof.
