ORDINANCE 2476.

An ordinance accepting and adding to the City of Tulsa, Oklahoma, a certain tract of land known as LLOYD ADDITION to the City of Tulsa Oklahoma, according to the recorded plat thereof, and declaring an emergency.

WHEREAS, a petition in writing has been presented to the Mayer and Board of Commissioners of the City of Tulsa, Oklahoma, signed by over sixty (60%) of the property owners of the tract of land herein described and designated as LLOYD ADDITION to the City of Tulsa, Oklahoma, said tract of land being in Tulsa County, Oklahoma, and lying contiguous to and adjoining the present corporate limits of said City which petition prays that said Board annex to the City of Tulsa said tract of land, and,

WHEREAS, it has been made to appear upon examination, by said Board that the tract of land herein described is platted into lots and blocks and is used for residential purposes, and it further appearing to said Board that the prayer of said petitioners should be granted and the land embraced in said petition, should be annexed to said City and that all things necessary to be done for the proper annexation of said tract of land to said City have happened and been performed, and that said action is for the benefit of all parties concerned.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA, STATE OF OKLAHOMA:

SECTION 1. That a tract of land hereinafter described, the same being known as LLOYD ADDITION to the City of Tulsa, Orlahoma, and adjoining the present corporate limits of said City, being more particularly described as follows, towit:

The North one-half (N2) of the NE of Section 35, Township 20 North, Range 12, East I.M . Tulsa, Oklahoma. ,

Be and the same is hereby annexed to said City of Julsa, to be known as LLOYD ADDITION to the City of Tulsa, Oklahoja, and the corporate limits of said City, be, and the same are hereby extended to include the above described tract of land, provided, however, that the said tract is admitted to the City of Tulsa, Oklahoma, upon the condition and subject to the granting of a perpetual easement by the owners of said tract of land to the City of Tulsa,
