COMPARED ORD INANCE NO. 2424.

An Ordinance accepting and adding to the City of Tulsa, Oklahoma, a certain tract of land known as TERWILLEGER HEIGHTS ADDITION to the City of Tulsa, Tulsa County, Oklahoma; according to the recorded plat thereof, amending Ordinance 2421, and declaring an emergency.

WHEREAS, a petition in writing has been presented to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, signed by the owner of the tract of land herein described and designated as TERWILLEGER HEIGHTS ADDITION to the CITY OF TULSA, OKLAHOMA, said tract of land being in Tulsa County, Oklahoma, and lying contiguous to and adjoining the present corporate limits of said city, which petition prays that said Board annex to said City of Tulsa, said tract of land; and,

WHEREAS, it has been made to appear upon examination by said Board that the tract of land herein described is platted into lots and blocks and is used for residential purposes; and it further appearing to said Borad that the prayer of said petition should be granted and the land embraced in said petition should be annexed to said City and that all things necessary to be done for the proper annexation of said tract of land to said City, have happened and been performed, and that said action is for the benefit of all parties concerned, NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TULSA,

SECTION 1. That a tract of land hereinafter more particularly described, the same being known as TERWILLEGER HEIGHTS ADDITION to the City of Tulsa, Oklahoma, and adjoining the present corporate limits of the said City, being described as follows, to-wit:

The East One Half (1/2 ) of the Northwest Quarter (1/4) of Section Eighteen (18) Township Nineteen North (19 N.), Range Thirteen East (13 E.), Tulsa County, Oklahoma. be, and the same is hereby annexed to said City of Tulsa, Oklahoma, to be known as TERVILLEGER HEIGHTS ADDITION, to the City of Tulsa, Oklahoma; and the corporate limits of said City, be, and the same are hereby extended to include the above described tract of land, provided however, that the said tracts are admitted to the City of Tulsa, Oklahoma, upon the condition and subject to the granting of a perpetual easement by the owners of said tracts of land to the City of Tulsa, Oklahoma, giving to the City of Tulsa, Oklahoma, a perpetual right and easement to enter, go upon and use any portion of the above described
