A strip of ground, not to exceed ten (10) feet in width on either side of the center line of said sewer line, as shown by the blue prints on file in the City Engineer's office of the City of Tulsa, the center line of said Twenty (20) foot strip, being more particularly described as follows, to-wit:

Beginning at a point on the East line of Lot 13, Block 1, Arlington Heights Addition, a distance of 80 feet from the Northeast corner of said lot; thence Southwesterly across said Lot to a point on the Southwest line of said Lot a distance of 130 feet from the Northwest corner of said Lot 13, Block 1, Arlington Heights Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof.
