ceipt of which is hereby acknowledged, have bargained, sold and conveyed, and by these presents

do hereby bargain, sell and convey to the party of the second part the following described

property, to-wit:

The Southwest quarter (SW2) of the Northeast quarter (NE2) of the Southeast Quarter (SE2); and the East Half (E2) of the Northwest Quarter (NW2) of the Southeast Quarter (SE2); and the West Half (W2) of the Northwest Quarter (NW2) of the Southeast Quarter (SE2); and the South Half (S2) of the Southwest Quarter (SW2) of the Northeast Quarter (NE2) of Section Nineteen (19), Township Twenty-one (21), Range Thirteen (13), containing 70 acres in Tulsa County, Oklahoma.

TO HAVE AND TO HOLD the aforesaid property unto the said party of the second part in trust.

The purpose and object of the trust herein created are as follows, that is to say, the parties of the first part, having invested the party of the second part with title to the aforesaid premises, and they the said parties of the first part, being temporarily out of the possession of said premises, have empowered and authorized, and by these presents do hereby empower and authorize the party of the Second part to recover possession of said premises, and to that end to institute and prosecute any action that might be necessary; and they authorize and empower the party of the second part to collect all rents and profits that have heretofore accrued or that may hereafter accrue to any of the parties hereto on account of the use and occupation of said premises; and the parties of the first part further authorize and empower the party of the second part to recover any oil and gas rentals, bonuses or royalties heretofore or hereafter accruing to any of the parties hereto; and in connection with the above and foregoing authority, the party of the second part is authorized to enter into any compromise or other agreement that she may find advisable in her efforts to accomplish the object and pure pose of the trust as herein declared, and to that end the party of the second part is empowered to convey said premises, if need be, in carrying out the object and purpose of the trust herein created.

The party of the second part accepts the trust imposed upon her by this instrument, and hereby undertakes to accomplish the object and purpose thereof, and obligates hereelf to make proper account to parties of the first part when this trust is duly and fully administered.

The title to the aforesaid premises having been vested in the party of the second part in fee simple by this instrument, the parties of the first part agree that the same shall not be revoked, anualled or in any wise impaired until the object and purpose of the trust shall have been accomplished.
