Shepherd, as trustees, in trust for the purposes hereinafter set forth, the following described real estate and premises situated in Thisa County, Oklahoma, to-wit:

Lots Six (6), Seven (7) and Eight (8) in block Forty-three (43) of the original Townsite of Sand Springs, according to the recorded plat thereof, subject to incumbrance of record in the sum of \$3100.00.

also the sum of \$5000.00 in cash and notes and other personal property particularly described in the inventory this day filed with said trustees and of the value of \$3100.00, and the said H. E. Hanna, Birl O. Shepherd, Phil Reppert and R. P. Shepherd as trustees hereby accept said property in trust upon the following terms and conditions, to-wit:

A trust is hereby created under the terms of Chapter Sixteen of the Session Laws of 1919 of the State of Oklahoma, entitled, " An Act supplemental to and amendatory of Article IV of Chapter 65, Revised Laws of Oklahoma, 1910."

Said trust estate hereby created shall be known as SAND SPRINGS LUMBER COMPANY, and said trustees shall conduct the business pertaining to it, in so far as practicable in said name.
