# Assignment of Oil and Gas Lease No. 478

NOW, THEREFORE, For and in consideration of One Dollar (and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner of an undivided one-half interest of the said lease and all rights thereunder or incident thereto, do hereby bargain, sell, transfer, assign and convey unto Fan-Elva Oil & Gas Company

all his right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the N<sup>1</sup>/<sub>2</sub> of the NE<sup>1</sup>/<sub>4</sub> Sec. 19, 19 North R. 10 East.

together with all personal property used or obtained in connection therewith to Fan-Elva Oil & Gas Company

and its heirs, successors and assigns. And for the same consideration, the undersigned for himself and his heirs, successors and representatives, do covenant with the said assignee, their heirs, successors or assigns, that he is the lawful owner of the said lease and rights thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
