

Assignment of Oil and Gas Lease No. 478

Oklahoma State Bar Association, Inc. 1940

Joseph M. Wren, an undivided one-sixteenth (1/16) interest (1/16)

of all the right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the above described land, together with an undivided one-sixteenth (1/16) interest in a completed well on said property in accordance with contract entered into this date between the assignor herein and Sam Morrison

together with all personal property used or obtained in connection therewith to Joseph M. Wren

And for the same consideration, the undersigned for himself and his heirs, successors and assigns, that he is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
