THIS AGREEMENT made and entered into this 4th day of September, 1923 by and between Edith A. Kosher and John J. Kosher, her husband, of Tulsa County, Oklahoma, parties of the first part and Guy Mills of Tulsa County, Oklahoma, party of the second part, WITNESSETH:

For and in consideration of the sum of Twenty nine Hundred Fifty (\$2950.00) Dollars payable as hereinafter provided by said second party to said first parties, the said first parties do hereby covenant and agree to sell, transfer and convey to the said second party upon the terms and conditions hereinafter set out, the following described property, towit:

The East Fifty (50) feet by Two Hundred eighty eight (288) feet of Lot Nine (9) Block Twenty seven (27) Park Place Addition to the city of Tulsa, Tulsa County, Oklahoma, as per the recorded plat thereof, being a tract of land Fifty (50) feet wide East and West and Two Hundred Eighty-eight (288) feet long North and South.

Upon the execution of this contract by the parties hereto the said second party, Guy Mills agrees to pay to the said first parties, in cash, the sum of Nine Hundred Fifty (\$950.00) Dollars.
