Whereas, The Texas Company, a corporation of Texas, is now the record owner of said oil and gas lease, and

Whereas: Ernest R. Anthis is now the owner of an undivided five-sixteenth (5/16) interest, and T. P. Clonts, an undivided two-sixteenth (2/16) interest, and Benjamin F. Wheeler an undivided four-sixteenth (4/16), and I. I. Litwinsky an undivided five-sixteenth (5/16) interest, being the whole interest in the above particularly described land covered by said oil and gas mining lease, and they desire that the Commercial National Bank of Muskogee, Oklehoma, be designated as their agent to receive all rentals and other payments provided for in said lease.
