Lots One (1) and Two (2) in Block Five (5) in Park View Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the recorded amended plat thereof, and improvements thereon, and furniture and household goods therein,

free and clear of any claims of the defendant, and the defendant is hereby forever estopped and barred from setting up or asserting any claims to the same.

IT IS FURTHER ORDERED, AND DECREED, That the plaintiff have and recover of and from the defendant as alimony the sum of \$100.00 to be applied on her attorney's fee to Kopplin & Jameson, in the prosecution of this action, and have and recover the costs of this action, of and from the defendant.

ASSIGNMENT OF RENTAL CONTRACT.

This indenture made this 23rd day of October, 1923, witnesseth:

COMPARED

That the Southwestern Mortgage Company of Roff, Pontotoc County, Oklahoma, and M. Hughes, trustee for the said Southwestern Mortgage Company, for and in consideration of the sum of One (\$1.00) Dollar in good and lawful money of the United States, and other good and valuable considerations and services, to the said Southwestern Mortgage Company and M. Hughes, trustee, paid by Hutchison Lumber Company, a corporation, of Tulsa County, Oklahoma, have sold and by these presents do sell, transfer, assign and set over unto the said Hutchison Lumber Company, a corporation, a certain assignment of rentals, in writing, executed by H. E. Markey, on the 6th day of June, 1923 covering:

Lot Seven (7) in Block Seven (7) Lynch-Forsythe Addition to the recorded plat thereof,

together with all the improvements thereon.

which said assignment was duly recorded in Record 457, at page 520, in the office of the County Clerk of Tulsa, County, Oklahoma, to have and to hold the same unto the said Hutchison Lumber Company, a corporation, its executors, administrators and assigns for its use and benefit forever.

And the said Southwestern Mortgage Company, and the said M. Hughes, trustee, hereby authorize and empower the said Hutchison Lumber Company to demand and to receive all of the rents under said assignment of rentals to be paid in said assignment of rentals in the manner and to all intents and purposes as the Southwestern Mortgage Company, and M. Hughes, as trustee, might or could do were these presents not executed.
