M O R T G A G E . COMPARED

THIS INDENTURE, Made this 6th day of November, 1923, between Merle C. Prunty and Grace M. Prunty, his wife, and Merle C. Prunty, the duly appointed, qualified and acting guardian of the estate of Merle C. Prunty Jr., a minor of Tulsa County, State of Oklahoma, parties of the first part, mortgagors, and GUM BROTHERS COMPANY, a corporation, of Oklahoma City, Oklahoma, party of the second part, mortgagee:

WITNESSETH, That whereas, on application of the said Merle C. Prunty, guardian of the estate of the minor hereinabove named, the County Court within and for the County of Tulsa, and the State of Oklahoma, did on the 5th day of November, 1923, enter an order authorizing and directing the said Merle C.
