KNOW ALL MEN BY THESE PRESENTS: That Young O. Mitchell, of the County of Tulsa, State of Oklahoma, Administrator of the estate of John O. Mitchell, deceased; the John O. Mitchell Company, a business trust located at Tulsa, Tulsa County, Oklahoma, and the trustees composing said company, Young O. Mitchell, Garland C. Mitchell, Edwin Harrison and Frank Newkirk; the Central Investment Company, a corporation incorporated under the laws of the State of Oklahoma, located at Tulsa, Tulsa County, Oklahoma; the Mitchell Oil and Gas Company, a corporation incorporated under the laws of the State of Oklahoma, located at Tulsa, Tulsa County, Oklahoma; Alice M. Mitchell, widow of John O. Mitchell, deceased, of Tulsa County, Oklahoma; Young O. Mitchell of Tulsa County, Oklahoma; Garland C. Mitchell of Claremore, Rogers County, Oklahoma; Belva M.
