AFFIDAVIT.

COMPARED

E. K. Robinett, of lawful age, being first duly sworn, deposes and says as follows:

That on or about the 18th day of February, 1920, he was practicing law in the city
of Tulsa, Tulsa County, Oklahoma, and that Anthony Lucas, Adam Szubertowicz and Bela Bogyo
called on this affiant and employed him to, and he did, from a partnership organization for
the purpose of purchasing and improving certain lots in the Terrace Drive Addition, which
was at that time being owned by E. E. Oberholtzer, of Tulsa, Oklahoma.

That a corner lot of approximately 300 feet in depth with a frontage on Terrace Drive of approximately 100 feet was included a strip of ground, which was the rear part of said corner lot and which was described as follows: The North Fifty (50) feet of Lot Fourteen (14) in Block Five (5) Terrace Drive Addition to the city of Tulsa, Tulsa County, Oklahoma, according to the recorded plat thereof.

That the said contract and agreement of copartnership provided that Anthony Lucas, being the heaviest investor in the copartnership, was to have fifty per cent (50%))of all the profits and losses of said business, and that Adam Szubertowicz and Bela Bogyo were to each have a one-fourth (1/4) interest in said enterprise of purchasing and developing said lots.

That pursuant to said contract the said parties did improve said lots by building two houses thereon, one of which fronted on Terrace Drive and the other one fronting on Utica street. That during the time when said lots were being improved Adam Szubertowisz died, leaving a widow and two children living in the State of Indiana. That A. F. Wasielewski, now deceased, was appointed the Administrator of the estate of said Adam Szubertowicz, deceased.

That there was a certain plat formed of said ground by the said E. E. Oberholtzer at the time the said property was transferred to the said Anthony Lucae, Adams Szubertowicz and Bela Bogyo, showing the location of the said improved portions of said lot. That there was a
