SHERIFF'S DEED ON FORECLOSURE OF MORTGAGE. **COMPARED**

This Indenture, Made this 15th day of December, 1923, by and between R. D. Sanford as sheriff of the County of Tulsa in the State of Oklahoma, party of the first part, and Harold Striker of the County of Tulsa, State of Oklahoma, party of the second part, witnesseth:

Whereas, on the 30th day of April, 1923, in the District Court in and for Tulsa County, State of Oklahoma, at the March term of said court, in a certain action therein pending, wherein Harold Striker was plaintiff and Catherine Butler, A.D. Butler, her husband, Mary Lind, Ben E. Lind, here husband, J. E. Simmons, B. E. Lind, Aetna Building & Loan Association of Topeka, Kansas, a corporation, L. A. Demory, Lou Anis Demory and Susie Whipkey were defendants, the said plaintiff, Harold Striker, by the consideration of the Court, recovered a judgment against said defendants Catherine Butler, A.D. Butler, her husband, Mary Lind, Ben E. Lind, her husband, J. E. Simmons, B. E. Lind, L. A. Demory, Lou Anis Demory and Susie Whipkey for foreclosure of a mortgage on the following described property situated in Tulsa County, Oklahoma, to-wit:

Lot 21, Block 4, East Highland Addition to the city of Tulsa, Tulsa County,

State of Oklahoma, according to the recorded plat thereof with all the

improvements and appurtenances thereto belonging,

to satisfy the judgment rendered at the same time in favor of the plaintiff and against Mary Lind for the sum of \$1,600.00 with interest from Sept. 26, 1920, at the rate of 8% per annum and \$50.00 attorney's fees and cost of this action; and the Court further decreed that said plaintiff had a second lien upon said property for said amount subject only to the mortgage held by the Aetna Building & Loan Association of Topeka, Kansas; and,

Whereas, said Ben E. Lind on Feb. 10, 1923, recovered a judgment against Susie Whipkey for the sum of \$1,379.73 with interest at the rate of 8% per annum from said date together with an attorney's fee of \$498.50; and the Court on April 30, 1923, further decreed that the said Ben E. Lind had a third lien on the above described property for said amount subject to the mortgage held by the Aetna Building & Loan Association of Topeka, Kansas, and the mortgage lien held by Harold Striker, the plaintiff herein; and,
