ORDINANCE NO. 2531.

An ordinance vacating a portion of HASKELL STREET from the East line of ELGIN PLACE which line is a one drawn from the northwest corner of Block 16, north, Tulsa Addition to City of Tulsa to the southwest corner of Block 3, Mountain View Addition to the City of Tulsa, to the West line of Frankfort Street, all in the City of Tulsa, Oklahoma, with certain re-deductions and declaring an emergency,

WHEREAS, a petition signed by all of the property owners owning property abutting on the strip of ground commonly known as HASKELL STREET in the Addition hereinbefore mentioned, has been presented to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, asking that a portion of the ground commonly known as HASKELL STREET, more particularly de-vacated and abandoned as a public street.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA,

SECTION 1. That a portion of HASKELL STREET, more particularly described above, be and the same is hereby vacated and abandoned as a public street of the City of Tulsa, Oklahoma, Provided, however, that the City of Tulsa hereby reserves and shall retain forever, the right to construct, reconstruct, repair, maintain and operate sanitary sewers and other appurtenances thereto appertaining, now located in said strip of ground, commonly known as HASKELL STREET, or which of necessity should be constructed or maintained in, said strip of ground, commonly known as Eighteenth Street, with the right of ingress and egress over said premises for the purposes above indicated and for said purposes four (4) feet on each side of the center line of said strip of ground, commonly known as HASKELL STREET, is hereby maintained by the City of Tulsa upon which said City of Tulsa may allow public service corporation companies, individuals or itself, to construct, maintain and operate facilities for public utilities, including poles, wires, pipes, conduits, and other necessary accessories, and

PROVIDED further, that four (4) feet on each side of the center line of said strip of ground, commonly known as Haskell Street, shall be construed to mean sufficient space near
