ORDER DETERMINING EXCEPTIONS AFTER
TRUSTEE'S REPORT.

The Trustee having more than twenty days since filed his report of exempted property in accordance with General Order XVII, and exceptions having been taken thereto by the bankrupt, and this matter having come on for hearing on said report and exceptions, before Honorable Ezra Brainerd, Jr., Referee in Bankruptcy, on this, the 2nd day of July, 1915, said bankrupt appearing in person and by her attorney, E. G. Wilson, and the trustee appearing in person and by his attorneys, Morse & Standeven, and after hearing evidence in support of the respective contentions, and having heard argument of counsel and being fully advised in the premises.

It is ordered and adjudged that the exceptions of the bankrupt to the report of the trustee be sustained in part and overruled in part; that said bankrupt is entitled to the following described real estate, situated in Tulsa County, Oklahoma, as exempted to her, to-wit:

Lot Nine (9) in Block Four (4) in North Tulsa Addition to the city of Tulsa, Tulsa County, Oklahoma, according to the recorded plat thereof;

that the balance of the real estate of said bankrupt, to-wit:

The East sixty-three (63) feet of the South forth-eight (48) feet of the north Fifty-eight (58) feet of Lot Eight (8) in Block Four (4) in North Tulsa Addition to the City of Tulsa, Tulsa County, Oklahoma,

is not exempted to said bankrupt, and the title to the same is vested in the trustee herein; that the report of said trustee as to exemptions of personal property is ratified and confirmed; that the property specified above as exempted to said bankrupt, be delivered to said bankrupt forthwith.

To the ruling of the Referee, an exception was allowed to said bankrupt, and to the trustee herein.
