AFFIDAVIT

COMPARED

Before the undersigned Notary Public in and for said State and County of New York, on this 27th day of October, 1923, personally appeared M. W. Thompson, who, being by me duly sworn, deposes and says:

1. In the spring of 1916, and until June 30, 1920, I was the senior partner of the firm of Thompson & Black, with offices at New York Detroit, Kansas City, and (during a part of the time) Tulsa; the name "Black" in the said firm being that of E.B. Black of Kansas City; however, the said Black had no part in the financial ownership and management of the said firm, but obtained his benefits therefrom out of preferential employment in engineering matters on a per diem basis for himself and his partners and staff in Kansas City.
2. On June 30, 1920, the firm of Thompson & Black was succeeded by the firm of Thompson & Worley, which firm assumed the going business of Thompson & Black and certain specified assets and liabilities appertaining thereto; while I took over the remaining assets, and assumed all other liabilities of Thompson & Black, in my own person, but for convenience and value of goodwill continued to handle the same under the style of "Thompson & Black", and still continue so to do.
3. That some years prior to June 30, 1922, I was the senior member of a firm of oil operators and drillers styled Thompson & Kennedy of Cleveland, Oklahoma, which firm was dissolved by mutual consent on the said date, whereby I took over certain assets in cash, receivables, and oil
