and gas leases. Upon the dissolution of the last mentioned firm I concluded to continue and extend my oil and ges operations, with headquarters at Thisa, Oklahoma, and to that end employed a staff, and opened offices at that point; and I have since then operated as an oil and gas producer in that territory, under the style of "Thompson & Black", said style having COMPARED in my belief a large goodwill value, which belonged to me.

4. And I further and especially say that I am the sole proprietor of the firm and business styled "Thompson & Black" operating thereunder as a producer of oil and gas at sundry points in Oklahoma and elsewhere, and with principal offices at 505 Atlas Life Insurance Building, in said City, and further, that under my directions all oil and gas leases purchased for said business were taken in my name, that is to say, in the name of M. W. Thompson, except oil and gas leases and assignments thereof as listed immediately below, which said leases and assignments were, by accident and mistake, conveyed to Thompson & Black, viz:

(I) A Certain original oil and gas mining lease by S. O. Barnes and E. S.
