SHERIFF'S ASSIGNMENT OF OIL AND GAS LEASES.

KNOW ALL MEN BY THESE PRESENTS: That Whereas, on the 16th day of July, 1923 in an action then pending in the District Court of Tulsa County, Oklahoma wherein Charles Lowery was plaintiff and A. M. Barr, A. T. Free, Elmer Hisson and the Security State Bank of Tulsa, Oklahoma, a corporation were defendants, cause No. 13972, consolidated with a certain other action then pending in the District Court of Tulsa County, Oklahoma wherein Security National Bank of Tulsa, a corporation was plaintiff and Oklahoma-Texas Producing & Refining Company, a corporation, H. Mueller as Receiver of the Oklahoma-Texas Producing & Refining Company, Ada M. Barr, otherwise known as A. M. Barr, and Accorn Petroleum Company, a corporation were defendants, cause No. 22810, the said plaintiff Charles Lowery by consideration of the court recovered a judgment foreclosing a materialman's lien securing the sum of \$791.50 with interest thereon at the rate of six (6) per cent per annum from the 30th day of September, 1920, and the said Security National Bank of Tulsa by the consideration of the court recovered a judgment for the foreclosure of a mortgage in the sum of Ten Thousand Dollars (\$10,000.00) with interest thereon at the rate of eight (8) per cent per annum from the 27th day of December 1922 and Twenty-nine hundred Sixty-eight (\$2968.00) with interest at the rate of ten (10) per cent per annum from the first day of July, 1922 and Thirteen Hundred Seven & 80/100 Dollars (\$1307.80) attorneys' fees and all costs of said action upon and covering the following described property situated in Tulsa County, Oklahoma, to-wit:

One certain oil and gas lease executed on the 4th day of April, 1919 by Ruben Krider and wife . lessor, to Oklahoma-Texas Producing & Refining Company, covering the following described land, to-wit:
