with all the improvements there on and appurtenances thereunto belonging and warrant the title This mortgage is given to secure the principal sum of Three Hundred Twentyof the same. five No/100 Dollars, with interest thereon at the rate of 10 per centum per annum, payable from date according to the terms of one certain promissory note described as follows to -wit:

> One promissory note dated November 27th, 1923, in the sum of \$325.00 due on or before March 27th, 1924, bearing interest at the rate of ten per cent per annum from date until paid; said note signed by the said J. M. Loyd and Violet B. Loyd, his wife, in favor of the said H. Horwits;

FIRST. The mortgagors represent that they have fee simple title to said land, free and clear of all liens and encumbrances, except first mortgage in favor of Title Guarantee & Trust Company of Tulse, Oklahoma, in the sum of \$800.00 as appears of record; and hereby warrant the title against all persons, waiving hereby all rights of homestead exemption, and waive the appraisement of said lands in case of sale under foreclosure.

SECOND. If said mortgagors shall pay the aforesaid indebtedness both principal and interest, according to the tenor of said note as the same shall mature, and shall keep and perform all the covenants and agreements in this mortgage, then these presents shall become void; Otherwise to remain in full force and effect.
