## RELEASE OF TRUST DEED

COMPARED

KNOW ALL MEN BY THESE PRESENTS:

480 THAT, WHEREAS, by instrument dated the 19th day of May, A. D. 1923 and filed for record on the 21st day of May A. D. 1923 and recorded in Book 455 at page 117 of the Title records of Tulsa County, Oklahoma, A. MILDER HAMMETT and ADELAIDE E. HAMMETT, his wife, did convey to W. L. LEWIS that certain tract or parcel of land situate in Tulsa County, State of Oklahoma and described as follows, to-wit:

All of the South Half (S $\frac{1}{2}$ ) of Lot Five (5), of Section Twenty-four (24), Township Nineteen (19) North, Range Twelve (12) East, lying South of a line parallel with, and 1607.5 feet North from the South line of Lot Eight (8) of Section Twenty-four (24), Township Nineteen (19) North, Range Twelve (12) East; also,

All of the North Half (N $\frac{1}{2}$ ) of Lot Eight (8) of Section Twenty-four (24), Township Nineteen (19) North, Range Twelve (12) East, except the North 16 $\frac{1}{2}$  feet of the South Half (S $\frac{1}{2}$ ) of said Lot Five (5), and except a strip of land off the East side of said Lots Five (5) and Eight (8), described as follows, to-wit: Beginning at a point on the East Line of said Lot Eight (8), 661.75 feet North of the Southeast Corner (SE/c) of said Lot Eight (8), thence North along the East line of said Lots Five (5) and Eight (8), to a point on the East of said Lot Five (5), 1607.5 feet North of the Southeast Corner (SE/c) of said Lot Eight (8), thence West a distance of 25 feet, thence South a distance of 945.75 feet, thence East a distance of 25 feet to point of beginning.
