Beginning at the Northeast corner of Lot 12, Block 8, Sunset Terrace Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; thence Southerly along the East line of said Lot12, a distance of seventy-five (75) feet; thence Westerly at a right angle to the East line of said Lot 12 a distance of four (4) feet; thence Northerly along a straight line to the North line of said Lot 12; thence Easterly along the North line of said Lot 12 a distance of four (4) feet, to the point of beginning,
