fied by such Ernest Schrimsher. This Court having examined such Return and having examined the said guardian in open court and it appearing to the satisfaction of the Court and the Court finds:

That in pursuance of said Order of Sale Ernest Schrimeher, guardian as aforesaid, caused notice of the time and place of holding said sale to be given by posting notices on three of the most public places in said Tulsa County, State of Oklahoma, and by advertising in the Collinsville News, a weekley newspaper printed and published in said Tulsa County, which notices were posted, published and advertised for more than fifteen days immediately prior to the day of sale, and in which said notices the land to be sold was described with common certainty.

That at the time and place of holding said sale specified in said notices and Ernest Schrimsher, guardian, caused to be sold at private sale on the following terms; Onehalf cash at the execution and delivery of a deed of conveyance thereof and the remainder to become due and payable one year after this date and such deferred payment to be secured by first mortgage security on the land sold, subject to the confirmation by this Court, the following described real estate, to-wit:
