FOR NON-PAYMENT TAXES. Seventhe Should the said mrtgagor, their heirs, legal representatives or assigns, fail to make payment of any taxes, assessments, fireinsurance premiums or other charges as herein provided, the said mortgagee, may at the option make payment thereof and the amounts so paid with interest thereonat ten per centum per annum shall be added to and become part of the debt secured by this mortgage without waiver of any rights arising from breach of any of the covenants, and for such payment with interest as aforesaid the premises hereinebfore described as well as the mortgagors, their heirs, legal, representatives, successors and assigns, shall be bound to the same extent that they are bound for the payment of the notes herein described.

Eighth - That the mortgagee shall be subrogated as further security for SUBROGATION. said indebtedness to the lien of anyland all encumbrances paid out of the peoceeds of the losn secured by this mortgage, although such encumbrances may have been released of record. ASSIGNMENT OF RENTS. Ninth- That as additional and collateral security for the payment of the dot hereinbefore described, said murtgagor herebybasigns to said mortgagee, its successors and assigns, all right title and interest in and to allrentals acruing to said mortgagor under any and all lesses of said real estate and directs any lessee, on demond, to pay said mortgagee, its successors and assigns, all rentals thatmay be properly due said mortgagor, heirs and assigns, under the terms of any suchlease, provided; that so long as no default is made in payment of the principal or interest hereby secured and so long as the covenants and conditions of this mortgage are faithfully performed the said mortgagor. heirs and assigns, shall retain possession of said real estate and shall be entitled to all income and profit derived therefrom; this assignmentof rents to cease abd determine upon release of this mortgage, or payment of the debt secured thereby PROVISIONS FOR APPOINTMENT OF RECEIVER. Tenth: In case any bill or petition, in an action brought to foreclose this mortgage, the Court may on motion of the mortgage, its successors or assigns, without respect to the condition or value of the property herein described appaint a Reciver to take immediate possession of the mortgaged premises, to maintain and lease the same, and to collect the rents and profits stising therefrom during the pendency of such fore closure and until the debt is fully paid and aply such rents and profts to the payment and satisfaction of the amount due under this mortgage, first deducting all proper charges and expenses attending the execution of said trust, and said mortgagee shall, in no case be held to account for any damages, nor for any rentals other than actually received. PROVISIONS FOR ATTORNEY'S FEES AND COSTS. Eleventh: In the event of this mortgage being foreclosed or of proceedings being brought for that purpose, or if said principal note be placed in the hands of an attorney for collection, the said mortgagors their heirs, legal representatives, successors and assigns, shall pay reasonable attorney's fees, and any expense incurred in procuring a supplemental abstract of title to said premises, with interest on such sums at the rate of ten per centum per annum, the same to be taxd as part of the cost of the case, for the benefit of the pointiff or complaint, and the same shall be a lien on the premises hereby mortgages, and shall be due and payable when acton is commenced, or when said principal note is placed in the hands of an attorney for collection; and for the consideration above mentioned the said mortgagor hereby expressly waives the oppraise ment of said real getate and all benefits of the hamestead and stay laws of said State. COST OF LITIGATION. Twelfth: If any action or proceeding be commenced (except an action to foreclose this mortgage on to collect the debt secured thereby) to which action or proceeding the holder of this mortgage is made a party, or in which it becomes necessary to defend or uphold the lien of this mrtgage, all sums paid by the holder of this mortgage for
