9. Upon the violation of any of the substantial terms and conditions of this lease the Secretry of the Interior (or lessor, in event restrictions are removed as provided in peregraph 12 hereo) shall have the right at any time after thirty days' notice to the lessee specifying the terms or conditions violated to delare this lease null and void, and the lesser shall then be entitled and authorized to take immedite possession of the land.

10. Before this lesse shall be in force and effect the lessee shall furnish a bond with responsible surety to the satisfactory of the Secretary of the Interior, and such further bond or bonds as may be required by said Secretary, conditions for the performance of this lesse, which bond shall be deposited and remain on file in the IndianOffice.

11: Assignment of this lease or any interest therein may be made with the approval of the Secretary of the Interior, it being understood that to secure such approval the proposed sarignee need only be easlified to hold such adease under the rules and regulations and furnish a bond with responsible surety to the satisfaction of the Secretary of the Ipterior. conditioned for the faithful perforance of the covenants and conditions of this lease.

In event restrictions on alignation shall be removed from all the leashold 12 premises described above, this lesse shall be released from the supervision of the Secretary of the Interior, such release to take effect without Asgreement, from the det Such restrictions are removed, and thereupon the authority and power delegated to the Secretary of the Interior as herein provided shall cease, and all payments required to be made to said Superintendent for the Fire Civilized Tribes, Muskogee.Oklahoma, shall thereafter be made to lessor of the then owner of said lands (in person or be deposited to the credit of said lessor or his assigns at the First National Bank of Bixby Okla. or such other place as the said lessor or his essigns may from time to time designate in writing, and changes in regulations thereafter made by the Secretary of the Interior applicable to ail and gas lease shall not apply to this lesse.

13. Each and every clause and covenant in this indenture shall extend to the heirs, executors, administrators, successors, and lawful assigns of the parties herato.
