ORDINANCE No. 2559.

An ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land within Tulse County, Oklehoma, described as follows: Beginning at the intersection of the east and west center line and the west line of section 6, township 19-north, range 13east, thence north slong said west line a distance of one hundred and nine-two and seven tenths (192.7) feet to the southerly line of the Missouri, Kanses and Texas Reilroad right of way, thence southersterly along said right of way line to its intersection with the east and west center line of said section 6; thence west along said center line a distance of four hundred and forty three and three9tenths (443.3) feet to the point of beginning, and declaring an emergency.

Whereas, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulse, Oklahoma, that the hereinafter described tract of land, situated in Tube County; Oklahome, lies contiguous to end adjoins the present corporate limits of the City of Tulse, Oklahome, on three or more sides.

Whereas; it further appears to the Mayor and Bard of Commissioners of said City that said trat of land hereinafter described abuts said Giyon three or more sides and should be annexed to the City of Tulss and entered within its corporate limits and that said fract of land does not exceed forty scres.

Now, therefore, be it ordained by the Mayor and Board of Commissioners of the City of Tubs, Oklahoma:

Section 1, that a tract of land abatting on three sides with the corporate limits of the City of Tulss, Oklahomeg situated in Tulsa County, Oklahoma, more particularly described as follows: to-wit :

Beginning at the intersection of the East and West Center line. and the Westline of section 6, township 19 north, range 13 east, thence north along soid Westtlike a distance of one hundred and ninetytwo and seven tenths (192.7) feet to the southerly lim of the Missouri, Kansas and Taxes Reilroad right of wayl thence southeasterly along said right of way line to its inbrsection with the east and west center line of said section six, thence west slong said center line a distance of four hundred and forty three and three tenths (443.3) feet to the point of beginning: be and the same is hereby added to and annexed to the said City of Tulsa, Oklahoma, and the corporate limits of said City be and the same hereby are extended to include said trat of lend for all purposes.

Section 3. That the City of Tulsa, Oklahoma, hereby retains and preserves a peretual, essement and right to enter upon and use any portion of the above described tract of land and to build, construct, lay, meintain, alter or repair any sower lines, water lines, gas lines, telephone lines, telegraph lines, electric lines or any other public utilities.

Section 3. That from and after this ordinance takes affect the real estate described in section 1, hereof, shall be part of the City of Tulsa, Oklahoma, and all persons residing there in and all property situated thereoh, shall be and are herby declared to be subject to all respects and particulars to the judisdiction, control and laws and ordinances of said City of Tulss, Oklahoma,

Section 4. That an emergency exists for the preservation of the public peace, health and safety, by reason whereof this ordinance shall take effect, from and after its passage, spprpyel and publication.

Passed and the emgergenpy clause ruled upon seperately at approved this 24th day of
