ORDINANCE No. 2569.

An ordinance adding and annexmg/o the City of Tulss, Oklahoms; a certain tract of land within Tulss County, Oklahoms, described as follows: to-wit: Beginning at a point on the ninety sixth 696th) Meridian and thirty (30) feet of the northwest corner of block 5, Morley Addition to the City of Tulss, Tulss County, Oklahoms, thence north along the ninety sixth (96th) Meridian, to the southwest/corner of Block 2, Oak Terrace Addition to the City of Tulss, Tulss County, Oklahoms; thence east along the south line of said block 2, and lot 6, block 3, Oak Terrace Addition, a distance of three hundred and twenty eight ( and fifty-eight hundredths (328.58) feet, thence south along/the west line of lots 7 and 8, Block 3, Oak Terrace addition, a distance of one hundred and thirty one and seven-tenths (131.7) feet; thence east adistance of fifty one and eighty five hundredths (51.85) feet to the northwest corner of north Denver Addition to the City of Tulss, Tulss County,Oklahoms; thence south along/the west line of north Denver Addition a distance of six hundred and sixty (660) feet, to the southwest corner of North Denver Addition, thence west along the north line of Morley Addition/to the point of beginning, and declaring an emergency,

Whereas, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that the hereinafter described tract of land, situated in Tulsa County Oklahoma, lies contiguous to and adjoinsunthe present corporate limits of the Cityof Tulsa, Oklahoma, on three or more sides.

Whereas, it further amears to the Mayor and Board of Commissioners of said City that the said tract of land hereinafter described abuts said City on three or more sides and should be annexed to and Cityvof Tulsa and entered within its corporate limits and that said tract of land does not exceed forty acres.

Now, therefore, be it ordsined by the Mayor and Board of Commissioners of the City of Tulsa. Oklahoma.

Section 1. That a tract of land abutting on three sides with the corporate limits of the City of Tulsa. Oklahoma, situated in Tusa County, Oklahoma more particularly described as follows, to-wit:

Beginning at a point on the hinety sixth (96th) Meridian and thirty(30) feet north of the northwest corner of block 5, Morley Addition to the City of Tulsa, Tulsa County, Oklahoma; thence north along the ninety-sixth (96th) Meridian to the southwest corner of Block 2, Oak Terrace AdditionActthe City of Tulsa, Thisa County, Oklahoma, thence east along the south liner of said block 2 and lot 6, Block 3, Oak Terrace Addition, a distance of three hundred and twenty sight and fifty eight hundredths (328.58) feet; thence south along the west line of lots 7 and 8, block 3, Oak Terrace Addition, a distance of one hundred and thirty one and seven-tenths (131.7) feet; thence east andistance of fifty pne and eighty five hundredths (51.85) feet to the Northwest corner of North Denver addition to the City of Tulsa, Tulsa County, Oklahoma, thence south along the west line of north Denver addition; thence west Amag the North line of Enrley Addition to the point of beginning, be and the same is hereby added to and annexed to the said City of Tulsa, Oklahoma, and the corporate limits of said City be and the same are hereby extended to include said tract of land for all purposes.

Section 2. That the City of Thise, Okhahome, hereby retains and reserves a perpetual essement and right to enter upon and use any portion of the shove described tract of land and to build, construct, maintain, after or repair any sewer lines, water lines, gas lines, telephone
