#### ORDINANCE NO. 2571.

An Ordinance adding and annexing to the City of Tulsa, Oklahoma a certain tract of land within Tulsa County, Oklahoma, described as follows, to-wit: Beginning at the northeast corner of the southeast quarter (SE $\frac{1}{4}$ ) of the northwest quarter (NW $\frac{1}{4}$ ) of section 2, township 19-north, range 2-east, said point of beginning being the northeast corner of Owen Place Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; thence south, along the center line of said section 2, a distance of four hundred and six and two-tenths (406.2) feet to the north line of the Missouri, Kansas & Texas Railroad right of way, thence southwesterly along said north right of way <sup>line</sup> a distance of one thousand and eighty-two and sixty six hundredths (1,082.66) feet to the southeast corner of block four, Hollywood Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; thence north along the east line of said block 4 to a point twenty five (25) feet north of the northeast corner thereof; thence east along a straight line a distance of two hundred and eighty three and twenty two hundredths (283.22) feet to the southeast corner of lot 6, block 1, of said Hollywood Addition; thence north a distance of one hundred and sixty five (165) feet to the northeast corner of lot 4, in said block 1, thence east along the south line of lot 1, block 1, Hollywood addition a distance of sixty-eight (68) feet to the southeast corner thereof; thence north along the east line of said lot 1, block 1, and said east line produced, a distance of three hundred and fifteen (315) feet; thence east a distance of four hundred and eighty (480) feet; thence south a distance of one hundred and fifty (150) feet to the north line of said southeast quarter (SE $\frac{1}{4}$ ) of the northwest quarter (NW $\frac{1}{4}$ ) of section 2, thence east along said north line a distance of one hundred and eighty (180) feet to the point of beginning, and declaring an emergency.

Whereas, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that the hereinafter described tract of land, situated in Tulsa County, Oklahoma lies contiguous to and adjoining the present corporate limits of the City of Tulsa, Oklahoma on three or more sides.

Whereas it further appears to the Mayor and Board of Commissioners of said City that the said tract of land hereinafter described abuts said City on three or more sides and should be annexed to the City of Tulsa, and entered within its corporate limits and that said tract of land does not exceed forty acres.
