Now, therefore be it ordsined by the Mayor and Board of Commissioners of the City of Tulsa, Okishoma: 335

Section 1, That a tract of hand abutting on/three sides with the corporate limits of the City of Tulsa, Oklahoma, situated in Tulsa County, Oklahoma, more particularly described as follows, to-wit:

Beginning at the northeast corner of the southeast quarter (SE2) of the northwest cuarter (NW4)nof section 2, township 19 north, range 125est, said point of beginning being the northeadt corner of OwenPlace addition to the Cityof Tuss, Oklahoma, according to the duly recorded plat, thereof; thence south slong the center line of soid section 2, s distance of four hundred and six and two tenths ((406.2) feet to the north line of the Missouri, Konsas and Texas Railroad right of way, thence southwesterly slong said north right of way line a distance of one thousand and eighty two and sixty six hundredths (1,082.66) feet to southeast corner of block 4, Hollywood addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; thende north along the east line of said block 4 to a point twenty five (25) feet north of the northeast corner thereof, thence east along a straight lihe a distance of two hundred and eighty three and twenty two hundredths (283.22) feet to the southeast corner of lot 6, Block 1, of said Hollywood Addition thence north a distance of one hundred and sixty five (165) feet to the northeast corner of lot 4, in said block 1 three east slong the southline. of lot 1, Block 1, Hollywood Addition, a distance of sixtyeightt (68) feet to the southeastcorner thereof; thence north along the eastline of sold lot 1, Block 1, and said east line produced a didtance of three hundred and fifteen (315) feet, thence east a distance of four hundred and eighty(480) feet; thence south a distance of one hundred and fifty (150) feet to the north line of soid southeast quarter (SE $\frac{1}{4}$) of the northwest quarter/of section 2; thence east along said north line a distance of one hundred and eighty (180) feetvto the point of beginning; be and the same is hereby added to and annexed to the seid City of Tulse, Oklahoms, and the corporate limits of soid City be and the same hereby are intended to include said tract of land for all purposes.

Section 2. That the City of Tulss, Oklahoma, hereby relains and reserves Saperpetal Essement and right to enter upon and use any portion of the above described tract of land and to build, construct lay, maintain, alter or repair any sewer/ines, water lines, gas lines, telephone lines, telegraph lines, electroic linesor any/ther/public utilities.

Section 3, That from and after this ordinance takes effect the real estate described in section 1, hereof shall be a part of the City of Tulso, Oklahoma, and all persons residing therein and all property situated thereon shall be and are hereby declared to be subject **in** all respects and particulars to the jurisdiction, control and laws and ordinances of said City of Tulso, Oklahoma.

Section 4, That an emergency exists for the preservation of the public peace, health and safety, by reason whereof this ordinance shall take effect from and after its passage, approval and publication.

Passed and the emergency clause ruled upon separately and approved this 24th day of December, 1923.
