

give the consent of a majority of the legal voters residing on said tracts of land that said tracts of land be added to and made a part of the City of Tulsa, Oklahoma, and which petitions also ask that the same be done; and

COMPARED

Whereas, it has been made to appear to the Mayor and Board of Commissioners, upon examination, that the tracts of land herein described are contiguous to and adjoin the present city limits of said city, and that said tracts of land are platted into lots and blocks and are being used for residential purposes; And it further appears to said Board that the prayer of said petitioners should be granted, and that said lands described in said petition and hereinafter described should be annexed to said City of Tulsa, and that said action is for the best interest of said city and the public and all parties concerned; and

Whereas, said Board of Commissioners has found that all steps necessary to consummate the annexation of said tracts of land to said city have been taken.

Now, therefore, be it ordained by the Board of Commissioners of the City of Tulsa, Oklahoma,

Section 1, that the tracts or parcels of land hereinafter described, lying contiguous to and adjoining the present corporate limits of said city, and more particularly described as follows, to-wit:

All of Block 1; the south half of blocks 2, 3, 4, and 5, the south half of the west half of block 7, and all of blocks 9, 10, 11, 12, 13, 14, 15, 16, 21, 22, 23, and 24, all in Orcutt addition to the City of Tulsa, according to the recorded plat of said addition; and also;

Block 1 and the north half of blocks 3 and 4 in Lakeview addition to Tulsa, Oklahoma, according to the recorded plat of said addition;

All in section 7, township 19 north range 13 east, and also

All that portion of Riverford addition, not now within the City limits, lying west of Elwood avenue, east of the Arkansas River, north of Buena Vista Place, and south of the Nola Childers allotment in section 11, township 19 north, range 12 east, according to the recorded plat of said addition;

and respectively described by metes and bounds as follows:

Beginning on the center line of Fifteenth Street and on the north extension of the east line of Block 1, in Orcutt addition. thence west to the center line of Utica Avenue; thence south along the center line of Utica Avenue to the east extension of the boundary line between lots 4 and 5 in Block 2 of Orcutt addition; thence west along said boundary line and the boundary line between lots 12 and 13 in said block 4 and the boundary line between lots 4 and 5 and 12 and 13 in block 5, and the boundary line between lots 4 and 5 and 12 and 13 in Block 6 and the boundary line between lots 4 and 5 in Block 7, in said addition, to the center line of the Alley in said block 7; thence south along the center line of the Alley in said block 7, to the south line of said block 7, thence west along the center line of block 7 and block 8 of said addition to the center line of Pearl Avenue, thence south along the center line of Pearl Avenue to the center line of Buena Vista Street or Capitol Street immediately north of Park Place addition; thence east along the center line of said Capitol Street to the center line of Forest Avenue; thence north along the center line of Forest Avenue to the center line of Wall of Seventeenth Street in Orcutt addition; thence east along the center line of Wall or Seventeenth Street to the southerly extension of the east line of Block 16 in Orcutt addition; thence north along the east line of said block 16 and Block 1 of said addition to the place of beginning; and also

Beginning on the east line of block 4 and on the boundary line between lots 6 and 7 in Lakeview Addition thence north along the east line of said block 4, and along the east line of block 1 in Lakeview addition to the north east corner of said addition; thence west
