RIGHT OF WAY AGREEMENT.

This agreement, made and entered into on this 31st day of December 1923, by and between W. E. Hardesty and Hennie Hardesty, his wife, hereinafter called the grantor, and Oklahoma Natural Gas Company, hereinafter called the grantee.

Witnesseth, that said grantor for and in consideration of the sum of \$20.00 dollars to him in hand paid by said grantee, the receipt of which is hereby acknowledged, and for and in consideration of the agreements and covenants hereinafter contained, does hereby grant to the said grantee, the right of way to lay, maintain, operate, relay and remove a pipe line 80 rods long, and located in accordance with plat of definite location on the back hereof, for the purpose of the transportation of Natural Gas, with right of ingress and egress to and from the same, on, over and through certain lands situated in the County of Tulsa, State of Oklahoma, described as follows, to-wit:

The northeast quarter of the northwest quarter of section 26,
township 19 north, range 12 east.

It is hereby mutually agreed between the parties hereto as follows:

1. That the said grantor is to fully use and enjoy the said premises except the easement for the purpose hereinbefore granted to said grantee.
2. That said grantee hereby covenants to bury its lines of pipe so that the same will not interfere with the cultivation of said premises.
3. That the Grantee shall have the right at anytime to change the size of its lines of pipe.
