

husband and wife, of Tulsa, Oklahoma, made, executed and delivered to the Commissioners of the Land Office of the State of Oklahoma and certain note for the sum of twenty eight hundred and no/100 (\$2800.00) dollars, and due June 15th, 1926, and bearing interest at the rate of five per cent per annum from date until paid and payable semi-annually, and secured by a real estate mortgage upon all of the following described real property situated in Tulsa County, to-wit:

Lot 4 of section 19, and lots 6 and 7 of section 20 all in township 18, north of range 13 E. 11M. containing 46.33 acres, more or less, according to the Government survey thereof,

said mortgage being recorded in the office of the Register of Deeds of Tulsa County, State of Oklahoma, on the 25th day of June, 1921, at 12:00 o'clock noon, and entered in book 371, at page 32 of Misc., and

The application of the borrower in this connection, to obtain partial release of the mortgage has been made and by the Secretary presented to the Commissioners of the Land Office on the 31st day of October, 1923, and the following proceedings, to-wit:

Re: Partial Release, Loan #14726, A. H. Craver, application for partial release of State's Mortgage in the connection was presented by the Board, by the Chief Clerk of the Farm Loan Division, requesting authority to accept partial payment of \$400.00 on State's note and to issue partial release of that portion of the security covered by State's mortgage, described as follows, to-wit:

A part of lot 4 of section 19, township 18 north of Range 13 east, described as follows, beginning at a point 766 ft. east of the southwest corner of said lot 4, running thence west a distance of 264 ft., then north a distance of 330 ft., thence west a distance of 264 ft. thence south a distance of 330 ft., to place of beginning, and containing 2 acres, more or less.

The matter was considered by the Board and it appearing that a reinspection of this land has been made and that partial release of the above described tract recommended by J. I. McDaniel Inspector, it was moved by Mr. Sneed and seconded by Mr. Nash, that the Loan Division be given authority to accept partial payment of \$400.00 and issue release of above described tract, consisting of approximately two acres, more or less, and the Chairman and Secretary are directed to prepare and execute release.

All vote aye; motion prevailed.

Now, therefore, know all men by these presents, that the commissioners of the Land Office, for and on behalf of the State of Oklahoma, in consideration of the premises, do hereby acknowledge complete satisfaction of the mortgage given by A. H. Craver and Ada M. Craver, husband and wife, to the Commissioners of the Land Office of the State of Oklahoma, and do hereby release and discharge said land from the lien in said mortgage insofar as it relates to the following land and none other, to-wit:

A part of lot 4 of section 19, township 18 north, of range 13, east, described as follows, beginning at a point 766 feet east of the southwest corner of said lot 4, running thence east a distance of 264 feet, thence north a distance of 330 feet; thence west a distance of 264 feet; thence south a distance of 330 feet, to place of beginning; and containing 2 acres, more or less.
