This indenture of losse, made and entered into in quadruplicate on this 23rd day of July, A.D. 1923, by and between Rebecca Harry, a single woman, of Bixby, Oklas, enrolled as a full blood citizen of the Creek Nation, Roll No. 1636, party of the first part, hereinafter designated as lessor, and D. A. Dads, of Bixby, Haskell, Oklahoma, party of the second part, herhafter designated as lessee, nunder and in pursuance of the provisions of the Act of Congress, approved Liey 27, 1908 (35 Stat. L.P.312) witnesseth:

- 1. The lessor, for and in consideration of one dollar, the receipt whereof is mackingwiedeged and of the royalties, covenants, stipulations and conditions hereinafter contained, and hereby agreed to be paid, observed and performed by the lessee, does hereby demise, grant, lease, and let unto the lessee, for thenterm of ten years from the date of the approval hereof by the Secretary of the Interior, and as much longer thereafer as oil on gas is found inpaying quantities, all the oil deposits and natural gas in or under the following described tract of land, lying within the county of Talas, and State of Oklahoma, to-with The southeast quarter of the southeast quarter of section 5, township \$6N, range 13E of the Indian Meridian and containing 40 acres, more or less, with the exclusive right to prospect for, extract, pipe, store and remove oil and natural gas, and to occupy and use so much, only of the surface of said land as may reasonable be necessary to carryon the work or prospecting for, extracting, piping storing and removing such oil and natural gas, also the right to obtain from wells or other soutces on said lands by means of pipe lines or otherwise a sufficient supply of water to carry on said operations, and also the right to use, free of cost, oil and natural gas as fuel so farsa necessary to the development and operation of said property.
  - 2. The lessee hady agres to payor cause to be paid to the Superintendent of the Hive Civilized Tribes. Muskogee, Okehome for the lessor, as royalty, the sum tof twelve & one helf por cent of the gross proceeds of allerude oil extracted from said land, such payment to be made at the time of sale of removal of the oil. And the lessee shall pay as royalty on such gas producing well three hundred dollars per annum in advance, to be calcu-1sted from the date of commencement of utilization. Provided, however, in the case of gos wellsof small volume, wheethe rock pressure is one hundred pounds or less, the parties hereto may subject to the approval of the Secretary of the Interior, agree upon a royalty, which will become effective as a part of this lease; provided, further, that incase of gas wells of small volume, or where the wells produce both oil and gas or oil, and gas and salt water to auch extent that the gas in unfit for ordinary domestic purposes, or where the gas from any well is desired for temporary use in conection with crilling and pumping operations on adjacent of near by tracts, the lessee shall have the option of paying royalties upon such gas rells of the same percentage of the gross proceeds from the sale of gas from such wells as is paid finder this lesse for royalty en oil. The lessor shall have the free use of gas for demestic purposes in his residence on the lessed premises, provided there shall be surplus gos produced on said premises over and above enoughto fully operate the same. Failure on the part of the lessee to use a gas producing well, which cannot profitably be utilized at the rate herein prescribed, shall not work a forfeiture of this lease so for as the same relates to mining oil, but if the lessee desires to rebin gas producing privileges, the lessee shall pay at rental of one hundred dollars per annum, in advancem calculated from date of discovery of gas, on each gas producing well, gas from which is not marketed or not utilized otherwise then for operations under this lease. Payments of annual gas royalties shall be made within twenty five days from the date suh royalties become due, other royalty payments to be made
