WHEREAS, on the 16th day of January, 1923, George Bloomenshine and Eva Bloomenshine, husband and wife, executed an oil and gas lease to F. L. Bartlett covering the NW 1/4 of Section 2, Township 21 North, Range 13 East, Tulsa County, Oklahoma, which said lease was duly filed for record on the 5th, day of April, 1923, and recorded in Book 446 at page 386 of the records of said county, and.

WHEREAS, said lease is now owned by The Texas Company, which company contemplates assigning the gas rights thereunder,

NOW, for and in consideration of the sum of \$1.00 to us in hand paid, we George Bloomenshine and Eva Bloomenshine, his wife, hereby agree that if The Texas Company, assigns the right to drill on said land for gas, and if such assignee drills a well for gas in the center of the north 40 of said tract that it will not be necessary and required under said lease that any other well be drilled on said tract to offset a well producing gas, even if such offset well is nearer to the line of said north 40 than the well drilled in the center of the tract. This agreement is conditioned upon the beginning of said well within 30 days from the date hereof, and if such well is not begun within 30 days, this agreement will be void and of no effect.

It is understood that this agreement applies to gas wells only and in no way applies to or affects the south 40 acres. Witness our hands this the 12th, day of October, 1923.
