AGREEMENT OF DISSOLUTION.

COMPARED

This agreement made and entered into this 6<sup>th</sup> day of February, 1924, A.D. by and between H. P. Craig, party of the first part, and E. H. Young, party of the second part.

Witnesseth: Whereas, said parties have heretofore been engaged as partners in the business of conducting a farm and raising hogs and cattle, and have conducted said business under the firm name of Waldorf Farm, which farm is located in Tulsa County, Oklahoma,

Whereas, said parties are the owners of the west half of the southwest quarter of section seven (7) township 20 north, range 14 east, of the Indian Base and meridian, containing .80 acres, more or less, as the case may be according to the United States Survey.

Whereas, said parties are also the owners of the northeast quarter of the southeast quarter of section twelve (12) township twenty (20) north, range thirteen (13) east of the Indian Base and Meridian, less right of way of Santa Fe Railway of 4.64 acres, and less City of Tulsa Water Right of Way, of 2.49 acres, containing in all 33.87 acres, more or less as the case may be, according to the United States Survey thereof,

Whereas, said parties are desirous of and have agreed to dissolve said partnership, and the same is hereby dissolved upon the following terms and conditions, to-wit:
