ensuing rental paying date, or provided the lesse begins or resumes the payment of rentals in the manner and amount herein above provided: and in this event the preceding paragraphs hereof governing the payment of rentals and the manner and effect thereof shall continue in force.

## COMPARED

9. In case said lessor owns a less interest in the above described land than the entire and undivided fee simple estate therein, then the royalties and rentals herein provided for shall be paid the said lessor only in theproportion which his interest bears to the whole and undivided fee.

10. The lessee shall have the right to use free of cost, gas, cil and water produced on said land for its operations thereon except water from the wells of the lessor. When required by lessor, the lessee shall bury pipe lines below plow depth and shall pay for damage caused by its operations to growing crops on said land. No well shall be drilled nearer than 200 feet to the house or barn now on said premises without written consent of the lessor. Lessee shall have the right at any time during or after the expiration of this lease to remove all machinery, fixtures, houses, buildings and other structured placed on said premises, including the right to draw and remove all casing.

11. If the estate of either party hereto is assigned ) and the privilege of assigning in whole or in part is expressly allowed), the covenants hereof shall extend to their heirs executors administrators, successors and assigns, but no change of ownership in the land or in the rentals or royalties shall be binding on the lessee until after notice to the lessee a and it has been furnished with the written transfer or assignment or a certified copy thereof

12. If the leased premises shall hereafter be owned in severalty or in separate tracts the premises, nevertheless, shall be developed and operated as one lease and all royalties accruing hereunder shall be treated as an entirety and shall be divided among and paid to such separate owners in the proportion that the acreage owned by each such separate owner bears to the entire leased acreage. There shall be no obligation on the part of the lessee to offset well on separate tracts into which the land covered by this lease may be hereafter divided by sale, devise, or otherwise, or to furnish separate measuring or receiving tanks. it is hereby agreed that, in the event this lease shall be assigned as to a part or as to parts of the above described lands, and the helder or owner of any such part or parts shall fail or make default in the payment of the proportionate part of the rent due from him or them, such default shall not operate to defeat of affect this lease in so far as it covers a part or parts of said land upon which the said lessee or any assignce hereof shall make due payment of said rontals.

13. Lessor hereby warrants and agrees to defend the title to the land herein described and agrees that the lessee, at its option, may pay and discharge any taxes, mortgages, or other liens existing levied, or assessed on or against the above described lands and, in event it exempses such option, it shall be subrogated to the rights of any holder or holders thereof and may reimburse itself by applying to the discharge of any such mortgage, tax or o orther lien, any royalty or rentals accuring hereunder.

14. Notwithstanding anything in this lease contained to the contrary, it is expressly agreed that if lessee shall commence drilling operations ut any time while this lease is in force, this lease shall remain in force and its forff shall continue so long as such operations are prosecuted and, if production results therefrom, then as long as such production continues.

15. If within the primary terms of this lease production on the leased premises shall cease from any cause, this lease shall not terminate provided operations for the drilling of a well shall be commenced before or on the next ensuing rental raying date: or, provided lesses begins or wesawes the payment of rentals in the manner and amount hereinbefore
