lien including therein the recovery of all costs, and expenses and a reasonable attorney's fee, as provided in the said note, in the sum of \$10,00 on each note, and ten per cent of the amount due on said notes: The party of the second part may take possession of said oil and gas mining lease and leasehold estate, and all property herein described, and maintain, operate and control, the said property, and apply all proceds derived therefrom after payment of royalties and opening expenses on the payment of said notes, until the obligatims therein described are fully paid, first party agreing to give the second party immed distely peaceable possession; or the party of the second part, may take possession of and sell all of said property and interest thereon described under the laws of the State of Oklahoma. applicable to foreclosure of chatel mortgages; or, upon any suit brought to recover the sums herein secured, second party is hereby authorized to apply for and have appointed a receiver of all the property and interest above described, as a matter of right and without any showing of insolvency, ofraud, insecurity, or mismanagement on the part of the party of the first part, and the part of the first part hereby waives all notice of the appointment of a receiver, and agrees that such receiver, at the option of the second party, may, hold, maintain and operate said property, including the running and the selling of all oil and gas produced therefrom, and apply the proceeds of the sale thereof to the payment of said indebtedness, until /said indebtedness. Costs and attorney's fees are fully paid, or sell and dispose of said property according to law for the payment thehef. Called area.

The party of the second part, in event of any of the covenants, conditions, promises or agreements hereof are violated or broken by such party, agrees, uponwritten demand, to execute any and all papers and instruments of writing necessary to make a valid sale of the said leasehold estate, and the said oiland gas produced therefrom for the satisfaction of the said debt, including any and all writings and instruments required by the oil pipe-line or oil purchasing commanies, and by the Secretary of the Interior of the United States, his regulations, or the Departent of Interior of the United States; and in event of the failure of refusal of the said party of the first part to execute such instrument for the with upon such demand, the President or any Vice-President of the party of the second part may execute such instrument or instruments of writing, for, and in the name of the party of the first part, as attorney infact, and the said President and the said Vice-Presidents and their successors in office are hereby irrevocably appointed and constituted the lawful attorneys of the party of the second part, for such purpose, with full power in the premises

All of the terms covenants and agreements herein shall bind and enure to the benefit of the parties hereto, their heirs: executors; administrators, successors and assigns.

In asmuch as the oil and gas mining leases here inabove described are subject to supervision and control by the Department of the Interior, it is agreed and understood by and between the parties hereto that all the terms, provisions and conditions of this agreement are subject to the lease provisions proper which are incorporated herein by reference to said original ail and gas leases, and are subject to all the rules and regulations of the Department of the Interior governing in the praises; and in the event any provision herein appears to conflict with any such lease provisions or with said rules and regulations it is understood that it is the purpose of the parties hereto to conform to said provisions and regulations and not to conflict herewith, and subject all rules of construction as may be necessary to cary out the provosions and intensions of his paragraph shall be be adopted.
