WHEREAS, parties have found it impractical to carry out said trust and the trustees thereof
 to-wit; P. E. Johnston, T. R. McElhatten and Sam Hohenstein have mutually agreed to terminate
 and dissolve said trust;

NOW, THEREFORE, said P. E. Johnston, T. R. McElhatten and Sam Hohenstein, Trustees of said
 express trust, known as Mid Continent Investment Company, do hereby transfer, quit-claim
 assign and convey unto Sam Hohenstein, his heirs and assigns, all of the right, title,
 interest and estate of said Mid-Continent Investment Company and of them as trustees thereof
 in and to the property hereinbefore described and in and to said contract and agreement here-
 tofore entered into on the 2nd day of November, 1923, by and between Albert J. Oskison, his
 wife of the one part and Sam Hohenstein of the other part,

Said trustees further certify and declare that no shares of interest or any beneficial
 interest of anykind or character was ever sold or agreed to be sold in and to said trust
 estate and they certify that no beneficial interest was ever acquired by anyone in and to said
 estate of the property conveyed to them other than the interest acquired by said trustees.
