

between J. H. Gaddy hereinafter called the Grantor, and Oklahoma Natural Gas Company hereinafter called the Grantee,

WITNESSETH that said Grantor for and in consideration of the sum of \$35.00 Dollars to him in hand paid by said Grantee, the receipt of which is hereby acknowledged, and for and in consideration of the agreements and covenants hereinafter, does hereby grant to the said Grantee the Right of Way to lay, maintain, operate, relay and remove a pipe line 140 rods long, and located in accordance with plat of definite location on the back hereof, for the purposes of the transportation of Natural Gas, with right of ingress and egress to and from the same, on, over, and through certain lands situated in the County of Tulsa, State of Oklahoma, described as follows, to-wit: The Northeast Quarter of the Northeast Quarter of Section 8, and the

West Half of the Northwest Quarter of the Northwest Quarter and the West Half of the East Half of the Northwest Quarter of the Northwest Quarter of Section 9, all in Township 17 North, Range 14 East,

IT IS HEREBY MUTUALLY AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS;

- 1- That the said Grantor is to fully use and enjoy the said premises, except the easement for the purpose hereinbefore granted to said Grantee.
- 2- That said Grantee hereby covenants to bury its lines of pipe so that the same will not interfere with the cultivation of said premises,
- 3- That the Grantee shall have the right at any time to change the size of its line of pipe
- 4- That the Grantee shall pay all damage to fences, crops and premises, which may be suffered by reason of laying, maintenance, ^{operation} or alteration of said lines of pipe, If not mutually agreed upon, said damages are to be ascertained and determined by three disinterested persons one thereof to be appointed by the owner of the premises, one by the Grantee, and the third by two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive,

This contract shall bind and run in favor of the respective parties hereto, their heirs, executors, administrators, successors and assigns,

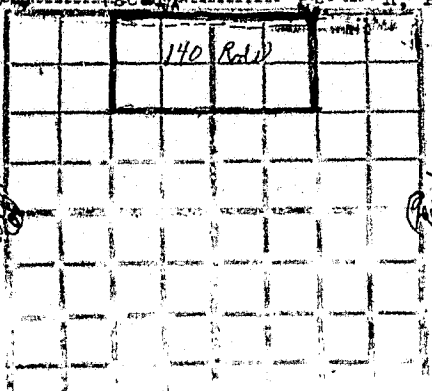
