IT IS HEREBY MUTUALLY AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS;

1- That the said Grantor is to fully use and enjoy the said premises, except the easement for the purpose hereinbefore granted to said Grantee.

2- That said Grantee hereby covenants to bury its lines of pipe so that the same will mot interfere with the cultivation of said premises,

3- That the "rantee shall have the right at any time to change the size of its line of pipe

4- That the ^Grantee shall pay all damage to fences, crpps and premises, which may be suffered by reason of laying, maintenance, or alteration of said lines of pipe, If not mutually agreed upon, said damages are to beascertained and determined by three disinterested persons onethereof to be appointed by the owner of the premises, one by the Grantee, and the third by two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive.


