THIS AGREEMENT made and entered into an this 7th, day of December 1923, by and between John T, Kramer hereinafter called the Grantor, and Oklahoma Natural Bas Company, hereinafter called the Grantee, Witnesseth that said Grantor for and in consideration of the sum of \$60,00Dollar to him in hand paid by said Grantee, the receipt of which is hereby acknowledged, and for and in consideration of the agreements and covenants hereinafter contained, does hereby grant to the said Grantee, the Right of Way to lay, maintain, operatem relay and remove a pipe line 240 rods long. and locatedin accordance with plat of definite location on the back hereof, for the purpose of the transportation of Natural Gas, with right of ingress and egress to and from the same. on over and through certain lands situated on the County of Tulsa , State of Oklahoma, described as follows, to-wit;

The North Half of the Northwest Quarter, and the Northwest Quarter of the Northeast Quarter of Section 8, Township 17 North, Range 14 East.

IT IS HEREBY MUTUALLY AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS;

1- Thet the said <sup>G</sup>rantor is to fully use and enjoy the said premises except the easement for the putposes hereinbefore granted to said Grantee,

2- That said Grantee hereby covenants to bury its lines of pipe so that the same will not interfere with the cultivation of said premises,


3- That the Grantee shall have the right at any time to change the size of its line of pip 4- That the Grantee shall pay all damage to fences, crops and premises, which may be suffered by reason of laying, maintenance, operation or alteration of said lines of pipe, If not mutually agreed upon, said damages are to be ascertained and determined by three disinterested persons, one thereof to be appointed by the owner of the premises, one by the Grantee, and the third by the two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive,
