COMPARED

An Ordinance accepting and adding to the City of Tulsa, Oklahoma, a certain tract of land known as WASHINGTON ADDITION, to the City of Tulsa, Oklahoma, according to the recorded plat thereof, and declaring an emergency.

WHEREAS, a petition in writing has been presented to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, signed by over sixty per cent (60%) of the property owners of the tract of land herein described and designated as WASHINGTON ADDITION to the City of Tulsa, Oklahoma, said tract of land being in Tulsa County, Oklahoma, and lying contiguous to and adjoining the present corporate limits of said City, which petition prays that said Board annex to said City of Tulsa, said tract of land; and,

WHEREAS, it has been made to appear upon examination, by said board that the tract of land here in described is platted into lots and blocks and is used for residential purposes, and it further appearing to said Board that the prayer of said petitioners should be granted and the land embraced in said petition, should be annexed to said City and that ell things necessary to be done for the proper annexation of said tract of land to said City have happen ed and been performed, and that said action is for the benefit of all parties concerned.

(NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA, STATE OF OKLAHOMA;

SECTION 1. That a tract of land hereinafter described , the same being known as WASHING TON ADDITION to the City of Tulsa, Oklahoma, and adjoining the present corporate limits of said City, being more particularly described as follows, to-wit:

A tract of lend beginning at the Northeast corner of the Northeast quarter of the South west quarter of Section 36. Township 20 North, Bange 12 East; thence South 4291' to the West line of Right of Way of the Sand Springs Railroad, thence in a Southwesterly direction with said Right of Way line to the C. I. of Haskell Street, 57.65' West of the C. L. of the Sand Springs Railroad, thence West 291, 15 to the C. L. of Greenwood Avenue, thence North 1320', thence East 662.4' to the point of beginning.
