be and the same is hereby annexed to said City of Julsa, to be known as WASHINGTON ADDITION to the City of Tulsa, Oklahoma, and the Corporate limits of said City, be, and the same are hereby extended to include theabove described tract of land, provided, however, that the said tract is admitted to the City of Tulsa, Oklahoma, upon the condition and subject to the granting of a perpetual easement by the owners of said tract of land to the City of Tulsa, Oklahoma) giving to the City of Tulsa, a perpetual right and easement to enter upon and use ny portion of the above described tract of land and to build, construct, lay, maintain, alter or repair any sewer lines, water lines, gas lines, telephone limes, telegraph lines, electric lines or any other public utilities and the said right of perpetual easement covering all of said tract of land is hereby accepted by the City of Hulsa, Oklahoma.

SECTION 2. That from and after this ordinance takes affect the real estate described in Section 1, hereof, shall be a part of the City of Tulsa, Oklahoma, and all persons residing therein and all property situated thereon, shall be and hereby are declared to be subject in all respects and particulars to the jurisdiction, control, and laws and ordinances of said City of Hulsa, Oklahoma.

SECTION. 3. That an emergency exists for the preservation of the public health, peace and safety, by reason whereof this ordinance shall take effect from and after its passage, approval and publication.
